## FY13 Outcomes: Impacting the Quality of Life for Everyone

promoting a healthier work force

The effectiveness of our **Comprehensive** Behavioral Health Counseling Program is measured by the extent to which we help clients resolve the issue that brought them into counseling. **88%** of our counseling program clients reported that they made progress on presenting issues during therapy and maintained progress six months later.

forever family is at the heart of our Adoption Services – In FY13, our Adoption

> Program placed **191** children with loving lifetime families.

Foster Care and Intact Family Services protect children from abuse and neglect, help them heal from trauma, and ensure every child has a safe and stable family to grow up in.

Greaking Cycles of Diolence

 Our Foster Care Program reunifies children when their families make the necessary changes to keep them safe or provides children with a "forever family" through adoption. In FY13, we helped **318** children across Central Illinois achieve their dream of a lasting, safe and caring family.

 Our Intact Family Program prevents abuse and neglect by helping families make lasting changes and provide a safe and nurturing home for their children. By engaging in our services and improving parenting skills, 90% of the families we served avoided foster care placement for their children.

counseling and volunteer companion services to older adults to address issues such as grief and depression, and prevent unnecessary nursing home care. **96%** of seniors we served were able to continue living independently.



84% of Home Confinement cases closed successfully and avoided juvenile detention.

> **96%** of the runaway youth we served in Crisis Intervention are back with their families.

**92%** of the youth in our after school tutoring programs advanced to the next grade level.

preventing juvenile crime



In FY13, **100%** of the youth discharged from our program moved to a family setting.
