These ideals guide our work every day.

We believe that positive change is possible even in the toughest of circumstances. We're committed to working with others to achieve solutions to the difficult problems people face. We trust in the power of collaboration prompting us to ally with our clients, network with other resourceful programs, and join with community supporters to advance our efforts. Respect, collaboration, and optimism that change is possible and solutions can be achieved – these beliefs shape our thinking about clients and influence our actions in every context.

In all that we do, we are committed to excellence. As Board President, I am pleased to share with you our significant achievements made possible by your support. We are proud to have served 18,937 clients last year. That includes 426 foster children now successfully joined with a safe, stable and nurturing family – one of the highest success rates in the state! Add to that 2,160 young people in crisis we helped avoid living on the streets, more than 7,400 counseling clients who reported relief from their problems, nearly 500 seniors we helped continue to live independently, and 228 children we placed with loving adoptive families. There is no doubt, CYFS is a significant community force for positive change across the life span.

If you're not convinced by statistics, then listen to the experts—our clients. An 11 year old foster child shared, "My caseworker has stood by me, when a lot of people haven't." A parent tells us, "My family's worker makes me feel like I'm still a mom. She makes me feel like she really wants what is best for me and my daughter and is helping us get there." An older adult commented, "My therapist has been a godsend. I really needed someone to talk to and I feel so much better getting it all out." These are real people talking about the genuine benefits of working with CYFS.

We are inspired by the gratitude of our clients. But make no mistake—we could not accomplish this without the support of others like you who share our vision. In the last year, volunteers provided more than 20,000 hours of compassionate service. Community members offered their financial support, essential to sustaining quality services that make a lasting difference. No program endures without firm roots planted in a supportive community. ## YOUTH, FAMILY, AND COMMUNITY OUTREACH SERVICES



Our Youth, Family, and Community Outreach Services team helped to stabilize **2**, **1** Oyouth and their families. Many of these family crisis situations occur when a teen has run away and parents are at a loss for how to help their child. We work with the family to de-escalate the immediate crisis and develop a safe plan for the youth.

Norman Services assist families whose children are at risk of placement in foster care or who cannot be reunited with their parents because the parents are unable to meet the children's basic physical needs. The primary focus of this program is to help families to obtain and maintain adequate housing.

## NEW DAY SENIOR SERVICES

This program provides in-home counseling, volunteer companion services, training and outreach to older adults who are facing such issues as depression, grief and loss, and a feeling of isolation. The program prevents costly and premature nursing home care.




